### Item No. 1 - Call to Order

President Frazer called the KMGA Board of Directors meeting to order at 10:33 a.m. at the Drury Plaza Hotel Broadview, Wichita, Kansas. A quorum was present.

Item No. 2 – Approve the Minutes of the May 8, 2019 Board of Directors meeting

Duane Banks made a motion to approve the minutes of the May 8, 2019, Board of Directors meeting. The motion was seconded by Gary Emry and carried unanimously.

# Item No. 4 – Move to adopt Resolution No. 64, a Resolution repealing Resolution No. 51 of the Agency and establishing a dues structure for Members and Affiliate Members

Paul Mahlberg provided background information on KMGA's favorable financial position over the last couple years which allows for a potential reduction in the dues and fees. Current dues are \$400 per year for the first 10,000 MMBtu's and \$0.004/MMBtu for over 10,000 MMBtu's. Affiliated Member dues are \$200 per year plus \$0.005/MMBtu for the first 10,000 MMBtu and \$0.002/MMBtu for annual volume above 10,000 MMBtu. Proposed Resolution No. 64 changes the dues to \$75/month for members and affiliate members that own and operate their natural gas system and \$35/month for member and affiliate members that do not own and operate their natural gas system, with no adder based on annual volumes. In addition to the potential reduction in the dues, the proposed 2020 budget eliminates the Project Participation Fee (\$50 per month if total volume is 50 MMBtu or greater). If approved, the changes would become effective January 1, 2020.

Jon Quinday made a motion to adopt Resolution No. 64, a Resolution repealing Resolution No. 51 of the Agency and establishing a dues structure for Members and Affiliate Members. The motion was seconded by Larry Berry and carried unanimously.

### Item No. 5 – Review the 2020 Annual Budget

### (a) Take action to adopt the 2020 Annual Budget

Paul Mahlberg presented the 2020 Annual Budget, highlighting the variances to the 2019 Annual Budget. In addition, the 2020 Budget assumes the new dues structure per Resolution No. 64 as well as elimination of the Project Participation Fee.

Robert Mills made a motion to adopt the 2020 Annual Budget. The motion was seconded by Gary Emry and carried unanimously.
