Item No. 1 - Call the Meeting to Order

Item No. 2 – Seek Approval of the following items:

- January 19, 2022 Executive Committee Meeting Minutes

Item No. 3 - General Manager Report

Paul Mahlberg provided the General Manager report, which included:

- Staffing Update Tyson McGreer started as Manager, Member Services. Laurie Brock has agreed to stay on as Director, Finance & Accounting for about a year. The attorney position will be posted soon.
- COVID Update We are still dealing with COVID contact/cases in the office.
- Infrastructure Bill Tyson will be looking at the Infrastructure Bill. There is money set aside for municipally owned gas systems. We have been participating in webinars and have spoken with a consultant that could potentially help KMEA/KMGA members obtain these moneys. It will be several months before the rules are written. We will keep members updated as information becomes available.

- Legislative activity in Topeka SB 480, a charitable giving bill which disallows, or caps expenditures related to dues, donations, or contributions from a utility, has been introduced into the utilities committee and applies to utilities across the board. KMEA, KMU, and Kimberly Svaty will be monitoring the bill closely.
- **City of Burlingame** Paul recapped the discussions held on January 26th with representatives from the City of Burlingame.
- Rate Recovery Plan Updates KGS, Black Hills, Atmos, Oklahoma Natural Gas, Centerpoint
- Oklahoma Attorney General Update The OK AG will not pursue the February event any further.

- Pipeline Capacity Policy Dixie reviewed KMGA's current Pipeline Capacity Policy that establishes an outline, process, and procedures for pipeline capacity utilized by non-capacity holders and suggested that we revisit the policy because the firm holders will be paying more transport costs when Southern Star's rate increase goes into effect on April 1st. Following discussion, staff was asked to bring a mark-up of recommended policy changes for consideration at the next meeting.
- Risk Management Consulting Service Paul reviewed the proposal we received yesterday from
 The Energy Authority (TEA) related to our natural gas hedging and procurement policy.
 Following discussion, the Committee asked Paul to reach out to TEA to see if we can refine the
 scope/expectations to get to a price that would be more doable.
