Item No. 1 - Call the Meeting to Order

Paul Mahlberg reported that PHMSA has released information about the Natural Gas Distribution Infrastructure Safety and Modernization Grant and application process for this year. He also reported that consultant Amanda Wood would be presenting a webinar at 1 p.m. today and will continue to monitor the program and provide monthly updates as additional information is released. Members were encouraged to reach out to staff if they need assistance with this process.

Item No. 5 - Gas Director Report

Dixie Riedel reported that there was an explosion at a Texas LNG terminal yesterday that exports about two BCF of LNG/day, and that the facility will be offline for at least three weeks. She also provided an update on current daily index pricing and NYMEX futures contract pricing.

Item No. 6 - Old Business

 Natural Gas Prepay Update – Paul shared details of a prepay program that RBC/MMGA closed in March. He informed the Committee that RBC/MMGA are in the early stages of developing a second prepay, provided details about the new program, and asked the Committee if they would like KMGA to consider participation. Following discussion, there was a consensus of the Committee to move forward and reach out to the membership to see if they want to participate.
