Item No. 1 - Call the Meeting to Order

Item No. 2 - Seek Approval of the following items:

- February 22, 2023, Executive Committee Meeting Minutes
 - Rod Willis made a motion to approve the February 22, 2023, Executive Committee meeting minutes. The motion was seconded by Mike Shook and carried unanimously.
- Financials for the month of January 2023

John Weber presented the January 2023 financials. He also reviewed the net equity chart, deliveries vs. budget volume chart, and legal fund balance.

Chad Buckley made a motion to approve the financials. The motion was seconded by Ethan Reimer and carried unanimously.

Item No. 3 - General Manager Report

Paul Mahlberg, Terri Pemberton and Dixie Riedel shared the following information:

- Terri provided an update on the lawsuit the Kansas AG has filed against Macquarie Gas. Terri said that KMGA will not get involved presently and will continue to monitor the situation.
- Dixie shared that the City of Rozel is selling their gas system to Black Hills, at present the timeline is uncertain.
- Dixie also mentioned that a company in Oklahoma has reached out to KMGA for information.
 It's a new company that's interested in helping cities in Oklahoma purchase gas and would like to learn more about how KMGA operates. We will continue to assist them as appropriate.
- Paul informed the members that KMGA is exploring other options for our gas supply/management needs and will provide more information during April's meeting.
- With the April board meeting approaching, Paul asked members if any member cities are using
 the preliminary budget for their purposes. The preliminary budget is presented during the April
 meeting, but in no members are using it, perhaps we could replace the budget presentation
 with a review of last year's financials. Paul asked members to let him know whether they are or
 aren't using it.

Item No. 4 - Gas Director Report

Dixie Riedel provided the Gas Director Report, which included:

- Industry News Dixie provided updates on industry trends on production, consumption, and exports.

• Gas Prepay Update – Dixie provided an update on the status of the prepay program and shared a list of all cities that are participating/not participating. In total, 15 cities have signed up to participate if the program goes forward.

Item No. 6 – New Business

 Paul shared that the City of Garnett is requesting that KMGA grant them an early termination of their contract. Member cities are required to provide a 1-year notice of termination. After a discussion, it was decided by the committee that Garnett would not be granted early departure from their contract. Previous cities that have made the same request have been denied. Ultimately, KMGA wants to maintain consistency among its member cities as much as possible.
