#### Item No. 1 - Call the Meeting to Order

Vice-President Mike Muirhead called the meeting to order at 10:30 a.m., which was held in person at the KMU Training Facility in McPherson, Kansas.

## Item No. 2 - RubinBrown 2023 Audit Report Review

Chester Moyer of RubinBrown provided an overview of the 2023 audit for KMEA. Chester noted that the audit resulted in an Unmodified Opinion (a/k/a "clean audit"), which is the highest opinion given. Additional items of discussion were:

- Implementation of a new accounting standard, GASB 96 regarding Subscription Based Information Technology, was applicable for the first time with the current reporting period, but the standard had no impact on KMEA.
- There was one uncorrected misstatement that would have increased interest revenue and reduced opening net position by \$138,000 that the management determined was immaterial to the financial statements as a whole.
- Segregation of Duties the 2022 audit results contained a footnote that work could be done to improve segregation of duties. Chester noted that the enhanced processes Mike Meyer has implemented within the division since that time, including the decrease in the number of bank accounts, have resulted in adequate segregation of duties.
- There were no significant deficiencies found.
- Bond Letter Chester noted that the Inflows and Outflows are adequate and in accordance with the bond agreements.

Stacie Eichem made a motion to accept the findings of the 2023 Audit Report. The motion was seconded by Dustin Bedore and passed unanimously.

### Item No. 3 – Seek approval for the following items:

Minutes from the March 28, 2024 Executive Committee Meeting

- Discussion on KMEA's role in providing a solution for behind-the-meter community solar was discussed. KMEA staff has identified Priority Power as a preferred option. Priority Power's structure is very transparent with a known developer fee up-front. Priority Power has developed a plan to evaluate solar in cities including an initial feasibility study followed by a more in-depth development study. If a city decides to move forward, then Priority Power will bid the materal and labor. Paul mentioned that this is just one option for the members. KMEA could also assist members that would rather utilize a request-for-proposal process. A presentation by Priority Power may be set up at a future meeting of the Executive Committee.
- Brad Mears of KMU provided a brief summary of recent legislative updates.
