- KCC Dockets (two dockets)
 - KGS Southern Star farm tap acquisition docket working on a procedural schedule right now.
 Do not expect any issues as KGS is aware of our position that they will need to unwind the Humboldt meter that was included in the purchase approval at FERC.
 - KGS American Energies purchase docket We have settlement discussions later this week.
 This affects the City of Hesston, but KGS is proposing to keep the tariff rates the same as what is currently on file.
- Winter Storm Uri Lawsuits We are still at a holding position on both the AG case and the Class Action suites the Judge will make a determination on whether the cases should be consolidated. Until that time, all deadlines for other pleadings have been stayed.
