Item No. 1 - Call the Meeting to Order

President Gus Collins called the meeting to order at 10:30 a.m., which was held virtually via Microsoft Teams. A quorum was present.

Item No. 2 – Seek approval for the following items:

• June 27, 2024 Executive Committee Meeting minutes

Gary Emry made a motion to approve the June 27, 2024, Executive Committee Meeting minutes. The motion was seconded by Stephanie Ashby and carried unanimously.

• June 2024 Appropriations Report

Mike Meyer presented the June 2024 Appropriations Report. Ethan Reimer made a motion to approve the June 2024 Appropriations Report. Tony Lawson seconded the motion, and the motion was carried unanimously.

• 2nd Quarter 2024 Financial Report

Mike Meyer presented the 2nd Quarter 2024 Financial Report. Gary Emry made a motion to approve the 2nd Quarter 2024 Financial Report. Ethan Reimer seconded the motion, and the motion passed unanimously.

Item No. 3 - Gas Director Report

Dixie Riedel presented the Gas Director Report, which included:

- Purchased Volume (Jan 2022 Dec 2024)
- Natural Gas Industry Update
- Daily Index Pricing (6/1/24 7/22/24)
- Projected Pricing (Aug 2024 Apr 2026)
- KMGA's Regional Meetings 2024 Schedule Cities of Lyons (July 31st), Osage City (August 12th), Kechi (August 13th), and Humboldt (August 21st).

Terri Pemberton provided updates on the following topics:

- Class Action Lawsuits Various pleadings and motions have been filed, as well as discovery and protective orders issued.
- AG Lawsuit Macquarie filed to dismiss, and the AG responded. Macquarie filed for an
 extension of time in which to file its reply.
- AG enforcement action on subpoena nothing new to report here. Presumably discovery is still underway, but nothing new has been filed or issued in the docket since December 2023.
- KCC cases are done

Item No. 5 - General Manager Report

Paul Mahlberg provided updates on the following topics:

- The date for the 2024 Annual Gathering has been set for September 26th.
- The 2024 Annual Conference will be held on October 23rd 24th this year and will have a slightly different format and timeframe.

Item No. 6 - Old Business

• 2024 Audit Consideration – Cash Basis Audit

Mike Meyer revisited the subject that was discussed at the KMGA Executive Committee meeting in June of changing the annual audit to a cash basis audit. A cash basis audit would incur less cost while still suiting the needs of the organization. Mike plans to come back with a formal proposal at the August KMGA Executive Committee meeting but won't seek approval until the September meeting.

Item No. 7 - New Business

City of Washington's Request for Termination

KMGA received a letter last month from the City of Washington requesting withdrawal of their KMGA membership. After staff discussions with the city, the city is also requesting early termination of the Gas Acquisition Agreement. The city is requesting termination due to new requirements being imposed by Kansas Gas Service (KGS) that require EFM (electric flow measurement) meters be installed on any meters not taking gas directly from KGS. These meters cost \$2,400 each to install and as Washington doesn't use much gas, they'd like to avoid this extra cost. Discussion ensued. Gary Emry made a motion to allow the City of Washington early termination from its Gas Acquisition Agreement with KMGA to be effective August 31, 2024. Tony Lawson seconded the motion, and the motion was carried unanimously. In accordance with the Interlocal Cooperation Agreement, withdrawal from KMGA membership must be voted on by the KMGA Board of Directors (BOD), so a resolution will be presented to the KMGA BOD at the 2024 Annual Conference for approval of this matter.

• KMGA Award Nominating Committee

The KMGA Awards Nominating Committee for 2024 has been established. The Committee will consist of past award winners Kim Everly and Pat Adams, as well as Tony Lawson. A discussion was had as to whether the awards structure for KMGA should change or stay the same moving forward. It was the consensus of the group that no changes were needed at this time.

• Executive Committee Meeting Structure Discussion Paul Mahlberg asked the Executive Committee to provide feedback on the current content of the meetings, the frequency of the meetings and preference on in-person versus virtual meetings. Terri mentioned that the governing documents do not require a certain number of meetings but allows the President/Executive Committee to determine the need for meetings. Discussion ensued on meeting frequency with potentially reducing the number of meetings per year. It was the consensus of the group to continue to have at least quarterly in-person meetings with possibly virtual meetings in-between. Paul mentioned that nothing needed to change at this time, and we would revisit the topic after a new Executive Committee is elected in October.
